Bug Fixes

Overview unassigned Personnel view misleading

On the Portal Overview screen, when a user selected Compliance to view Personnel Compliance data, and then selected 'Unassigned' from the Position column graph, no Personnel would populate in the Personnel detail or Certifications table below.

The list of Personnel who have not been assigned a Compliance position is not relevant in this case as data is populated based on Compliance. The decision was made to remove the Unassigned column from the graph in relation to Compliance only.

The list of Personnel 'Unassigned' to a Compliance position will still populate when Personnel is selected from the first table.

Personnel removed from all resource pools removed from Project Roles

Personnel were able to be removed from all Resource Pools and remain 'active' in a Project Role. This results in a conflicting state as the person is no longer connected to the Supplier and as such should be removed from the role.

This has now been resolved and the act of removing personnel from all Resource Pools will result in the person's current engagement being end dated to today and should they have future roles, they will be removed.

Personnel disconnecting from Supplier must end project engagement

When a Personnel's connection to the Supplier with whom a Project engagement was made was removed, they remained 'active' in a Project Role.

This has now been resolved and should the person disconnect from the Supplier within their passport, any current engagements will be end dated to today, while they will be removed from any future engagements.

API - Certificate type attribute causing issues

When trying to add Additional Requirements to a Role, the user was able to search and select the requirement but it was not populating or saving on the system.

This was occurring, specifically for Medical types of certificates.

This issue occurred due to the addition of a field name (Type) by MyPass to the API. The Business Partner already had this field name in use, as such a new attribute (skillType) was added to the response of the following endpoint to facilitate the Business Partners requirement:

`/workers/sync`

Error when Inviting and Adding Workers to the Pool

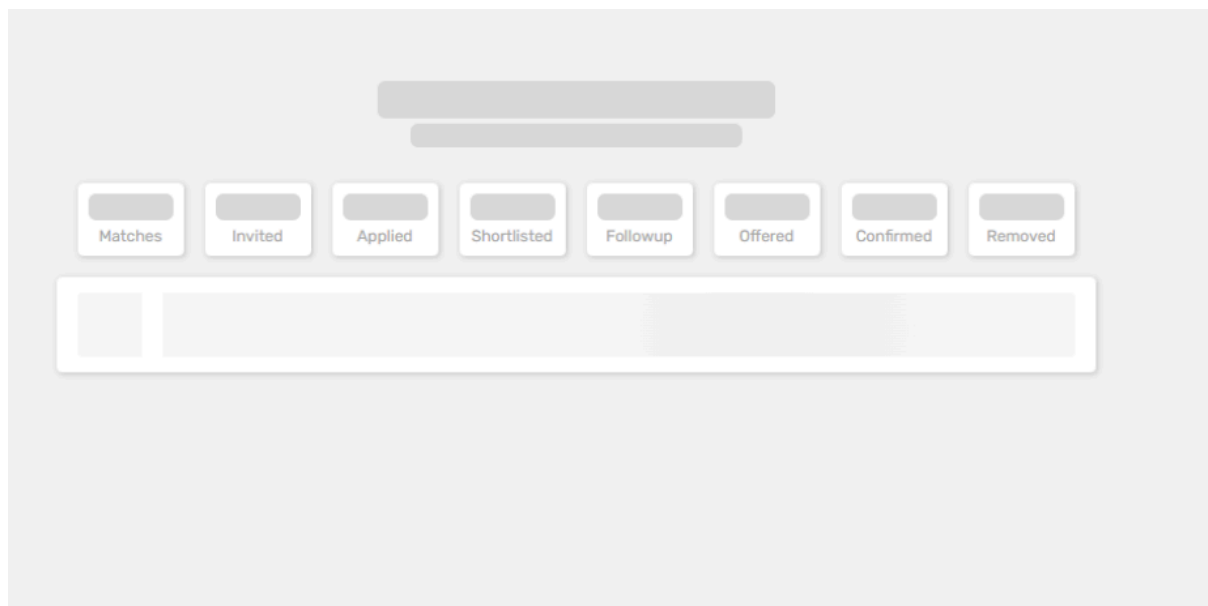
When a Business Partner had reached their subscription limit and then tried to 'Invite Personnel' or 'Add Personnel to a Resource Pool', an error message would appear.

This has been resolved with the user now being directed to the Subscription page. This will display active vs subscription numbers for review and allow users to upgrade their subscription.

Project role is not loading

A project role was not loading as expected and upon further investigation it was confirmed that a certificate, which was part of a certificate group assigned as a role requirement, was made inactive. As such the role page would remain blank and continue loading.




To prevent the issue going forward, the role requirements certificate groups containing inactive certificates will be taken into account, enabling the loading of the role.
